

Dragonbane Third-Party Tabletop Module License (Draft)

Fria Ligan AB (“Free League”) has created the Dragonbane tabletop role playing game, first edition (published by Fria Ligan AB in 2023) (“Dragonbane”). Subject to the terms of this license agreement, you may create your own tabletop role playing game modules that are compatible with Dragonbane. By creating such a module, you agree to these terms.

- LICENSE.** Free League hereby grants you a worldwide, perpetual, non-exclusive right to create, sell, publish, and distribute tabletop role playing game modules that are explicitly compatible with Dragonbane (your “Module”), in printed form, as a PDF, or as a virtual tabletop module (“VTT”). VTTs do not include NFTs or video games, only virtual tabletop modules. This agreement applies only to English language Modules based on the first edition of Dragonbane. Modules in any other language or based on any future editions are subject to separate licensing requirements. So long as you comply with the terms of this agreement, this license is irrevocable. If you breach the terms of this agreement, this license terminates automatically.
- SCOPE OF LICENSE.** This agreement permits you to create a module based on the Dragonbane rules, but not to include a copy of those rules with your module. You may reference the Dragonbane rules, including using terminology, the names of creatures, and locations from Dragonbane in your Module, so long as you do not use them in your title. This agreement also permits you to include page references to official Dragonbane publications in your Module. You may explicitly state that your publication is a third-party module for Dragonbane, for example on the back cover, on sales platforms, and in promotional material.
- LOGO.** You must place the A Module For Dragonbane logo (in one of the four versions available here) (the “Logo”) on any Module you create using this license. The Logo must be placed on the lower half of the cover and may not be wider than half the width of the cover. The Logo style and positioning must comply with any style guides provided by Free League.
- RULE MODIFICATIONS.** The purpose of this license is to encourage third party publications compatible with the Dragonbane core game, and with each other. Though not prohibited, Free League discourages the adoption of new rules for your Module. You may, however, include additions to the Dragonbane rules in your Module, subject to the following limitations: (i) your Module rules may not replace the official core rules, in whole nor in part; and (ii) you may not add new attributes or core skills. You are allowed to add new kin, innate abilities, professions, secondary skills, heroic abilities, magic schools, spells, weapons, armor, equipment, and rules for anything not covered by the core game.
- EXCLUSIONS.** Except as expressly permitted herein, you may not use any Dragonbane text, artwork, or trade dress, any other artwork, text, or other materials created or owned by Free League. You also may not use any of Free League’s brands or logos, except as set forth in section 3, above.
- OWNERSHIP OF DRAGONBANE.** You agree that Free League owns all rights in Dragonbane and that you will not contest those rights. Free League expressly reserves all rights not expressly granted in this agreement.
- OWNERSHIP OF YOUR MODULE.** You own all rights in any Module you make under this agreement. Free League may not copy or use your Module without your permission. But you acknowledge that Free League may independently create something similar to your Module and that it is not prohibited from doing so unless it knowingly and intentionally copied your original work.
- NOTICE.** You must include a notice on your Module, or any website or advertising material associated therewith, that states that your Module is not sponsored or endorsed by Free League and that you are using Dragonbane under license. We recommend, “This game is not affiliated with, sponsored, or endorsed by Fria Ligan AB. This Module was created under Fria Ligan AB’s Third-Party Tabletop Module License.”
- RESTRICTIONS.** Except as expressly permitted in this agreement, you may not state or imply that Free League endorses, sponsors, or is affiliated with your Module.
- REPRESENTATIONS.** You represent and warrant that you have the capacity to enter into this agreement, that your Module does not violate or infringe the rights of any third party, and that your Module complies with all applicable laws, rules, and regulations in every jurisdiction in which it is distributed.
- INDEMNITY.** You hereby agree to indemnify, defend, and hold Free League harmless from and against any claims, demands, actions, or losses of any kind arising from or relating to your Module or your breach of any representations or terms of this agreement, including any costs or attorneys’ fees, except for a claim that Dragonbane itself infringes a third parties’ copyrights.

12. **DISCLAIMER.** FREE LEAGUE IS PROVIDING DRAGONBANE “AS IS,” MAKES NO REPRESENTATIONS OR WARRANTIES EXCEPT AS EXPRESSLY STATED IN THIS AGREEMENT, AND DISCLAIMS ALL WARRANTIES, EXPRESS, IMPLIED, STATUTORY, OR OTHERWISE. Free League has no liability for your use of Dragonbane and, in addition, you expressly waive any claim for any indirect, punitive, special, exemplary, incidental, or consequential damages.
13. **MISCELLANEOUS.** This is the entire agreement of the parties relating to the subject matter hereof and you agree that you have not relied on any terms or representations other than those expressly stated herein. Free League

recommends that you review this agreement with your own lawyer and you acknowledge that you have had an opportunity to do so. Free League may update this agreement at its sole discretion, but you will continue to have the right to use Dragonbane under the terms of the version that was in effect at the time you created your Module. No joint venture, partnership, employment, or agency relationship exists between you and Free League as a result of this agreement. Free League’s failure to exercise any right or provision in this agreement shall not constitute a waiver unless expressly acknowledged and agreed to by Free League in writing.
