

Coriolis – The Third Horizon Third-Party Tabletop Module License (version 1.0)

Fria Ligan AB (“Free League”) has created the Coriolis – The Third Horizon tabletop role playing game, first edition (published by Fria Ligan AB in 2017, also under the brand name Coriolis Mörkret mellan stjärnorna) (“Coriolis – The Third Horizon”). Subject to the terms of this license agreement, you may create your own tabletop role playing game supplements that are compatible with Coriolis – The Third Horizon. A supplement is defined as a publication that includes adventures, setting material or rules additions, and requires the Coriolis – The Third Horizon core game to be used. It cannot be a standalone product. By creating such a supplement, you agree to these terms. For clarity, the later game edition Coriolis: The Great Dark is not covered by this agreement.

- 1. LICENSE.** Free League hereby grants you a worldwide, perpetual, non-exclusive right to create, sell, publish, and distribute tabletop role playing game supplements that are explicitly compatible with Coriolis – The Third Horizon (your “Supplement”), in printed form, as a PDF, or as a virtual tabletop module (“VTT”). VTTs do not include NFTs or video games, only virtual tabletop modules. This agreement applies only to Supplements based on the first edition of Coriolis – The Third Horizon published in one of the following languages: English, Swedish, Spanish, German, French, Portuguese, Italian, Polish. Supplements in any other language or based on any future editions are subject to separate licensing requirements. So long as you comply with the terms of this agreement, this license is irrevocable. If you breach the terms of this agreement, this license terminates automatically.
- 2. SCOPE OF LICENSE.** This agreement permits you to create a Supplement based on the Coriolis – The Third Horizon rules, but not to include a copy of those rules with your Supplement. You may reference the Coriolis – The Third Horizon rules, including using terminology, the names of creatures, and locations from Coriolis – The Third Horizon in your Supplement, so long as you do not use them in your title. This agreement also permits you to include page references to official Coriolis – The Third Horizon publications in your Supplement. You may explicitly state that your publication is a third-party Supplement for Coriolis – The Third Horizon, for example on the back cover, on sales platforms, and in promotional material.
- 3. LOGO.** You must place the A Supplement For Coriolis – The Third Horizon logo (available [here](#) in the relevant languages) (the “Logo”) on any Supplement you create using this license. The Logo in the language matching the

content must be placed on the lower half of the cover and may not be wider than half the width of the cover. The Logo style and positioning must comply with any style guides provided by Free League.

- 4. RULE MODIFICATIONS.** The purpose of this license is to encourage third party publications compatible with the Coriolis – The Third Horizon core game, and with each other. Though not prohibited, Free League discourages the adoption of new rules for your Supplement. You may, however, include additions to the Coriolis – The Third Horizon rules in your Supplement, subject to the following limitations: (i) your Supplement rules may not replace the official core rules, in whole nor in part; and (ii) you may not add new attributes or skills. You are allowed to add talents, concepts, mystical powers, cybernetic implants, bionic sculptures, weapons, armor, equipment, vehicles, ships, and rules for anything not covered by the core game.
- 5. EXCLUSIONS.** Except as expressly permitted herein, you may not use any Coriolis – The Third Horizon text, artwork, or trade dress, any other artwork, text, or other materials created or owned by Free League. You also may not use any of Free League’s brands or logos, except as set forth in section 3, above.
- 6. OWNERSHIP OF CORIOLIS – THE THIRD HORIZON.** You agree that Free League owns all rights in Coriolis – The Third Horizon and that you will not contest those rights. Free League expressly reserves all rights not expressly granted in this agreement.
- 7. GENERATIVE A.I.** If you include any text or art created by generative A.I. tools in your Supplement, this must be clearly stated when you offer the Supplement for sale and stated on the front or back cover of the Supplement.
- 8. OWNERSHIP OF YOUR SUPPLEMENT.** You own all rights in any Supplement you make under this agreement. Free League may not copy or use your Supplement without your permission. But you acknowledge that Free League may independently create something similar to your Supplement and that it is not prohibited from doing so unless it knowingly and intentionally copied your original work.
- 9. NOTICE.** You must include a notice on your Supplement, or any website or advertising material associated therewith, that states that your Supplement is not sponsored or endorsed by Free League and that you are using Coriolis – The Third Horizon under license. We recommend, “This game is not affiliated with, sponsored, or endorsed by Fria Ligan AB. This Supplement was created under Fria Ligan AB’s Coriolis – The Third Horizon Third Party Supplement License.”



10. RESTRICTIONS. Except as expressly permitted in this agreement, you may not state or imply that Free League endorses, sponsors, or is affiliated with your Supplement.

11. REPRESENTATIONS. You represent and warrant that you have the capacity to enter into this agreement, that your Supplement does not violate or infringe the rights of any third party, and that your Supplement complies with all applicable laws, rules, and regulations in every jurisdiction in which it is distributed.

12. DISCLAIMER. FREE LEAGUE IS PROVIDING Coriolis – The Third Horizon “AS IS,” MAKES NO REPRESENTATIONS OR WARRANTIES EXCEPT AS EXPRESSLY STATED IN THIS AGREEMENT, AND DISCLAIMS ALL WARRANTIES, EXPRESS, IMPLIED, STATUTORY, OR OTHERWISE. Free League has no liability for your use of Coriolis – The Third Horizon and, in addition, you expressly waive any claim for any indirect, punitive, special, exemplary, incidental, or consequential damages.

13. MISCELLANEOUS. This is the entire agreement of the parties relating to the subject matter hereof and you agree that you have not relied on any terms or representations other than those expressly stated herein. Free League recommends that you review this agreement with your own lawyer and you acknowledge that you have had an opportunity to do so. Free League may update this agreement at its sole discretion, but you will continue to have the right to use Coriolis – The Third Horizon under the terms of this agreement or any subsequently published version of this agreement at your sole discretion. No joint venture, partnership, employment, or agency relationship exists between you and Free League as a result of this agreement. Free League’s failure to exercise any right or provision in this agreement shall not constitute a waiver unless expressly acknowledged and agreed to by Free League in writing.
